The Role

Job title:	Learning Technologist

Purpose

To support the Learning Technology team in providing technical and creative expertise, specialising in online and blended learning, including transnational education.

To provide training to staff and students so that they are familiar with the learning technology tools and processes used in academic delivery.

To support the Learning Technologists in designing and developing a wide range of digital resources to enhance teaching and learning and make the RAU the UK's global university for sustainable farming and land management.

Key Responsibilities

- 1. Work with the Learning Technology and wider Digital Innovation team to provide face-toface and online training and guidance for core Learning technology and IT systems to Academic and Professional Services staff as well as students. Examples of core systems include Turnitin, Moodle, Panopto and Office 365.
- **2.** Respond to technical and pedagogic queries.
- **3.** Develop and maintain training resources in a range of accessible formats and media for a wide range of users.
- **4.** Plan, design and deliver innovative and engaging training and development activities for students and academic and professional services staff.

- **5.** Provide specialist, professional advice and expertise to support informed decision-making in the use of learning technologies to enhance online and face-to-face teaching.
- **6.** Provide support to transnational partners from onboarding and normal delivery to ensure that transnational students receive an equivalent and positive teaching and learning experience.
- **7.** Support the Learning Technology team in working with academic and professional services staff to enhance and modernise the digital teaching and learning environment for transnational, on-campus, distance and blended learning students.
- **8.** Provide support for the updating and testing of learning technology software including Moodle, Turnitin and Panopto
- **9.** Support the Learning Technology team in designing and developing innovative, effective and accessible digital resources to support teaching and learning, including interactive, multi-media and video elements.
- **10.** Support pedagogical initiatives that improve the student learning experience and collaboration between our transnational partners.
- 11. Support the Learning Technology team in the identification, evaluation, testing and implementation (including training) of new digital learning tools and technologies, as well as in the maintenance and development of RAU's existing digital learning tools and technologies.
- **12.** Where required, participate in the coordination of the timely delivery of digital content for both internal and external academic staff.
- **13.** Maintain high standards of service through effective verbal and written communication and a positive collaborative approach, supplying data and reports as required.
- **14.** Assist with measurement of services against key performance indicators.
- **15.** Work to ensure compliance with relevant legislative requirements including data protection, product licensing copyright compliance and accessibility.
- 16. Represent the department at internal committees and meetings.
- **17.** Work outside of standard working hours when required, adopt a flexible approach and undertake other tasks as required
- **18.** Keep up to date with personal and professional development.

General responsibilities:

The post holder must ensure that the confidentiality of personal data remains secure and that restricted information or highly restricted information to which they have access remains confidential during and after their employment at Royal Agricultural University. All staff must undergo appropriate data protection training as required.
- All absence from work must be reported in accordance with the University's absence procedures and recorded on iTrent.

 its employees, service users and visitors. It is the policy of the University not to allow smoking
 on University premises other than in specifically designated areas.
